



**Africa Maximum Safaris CC Reg No. 95/12955/23**

**Indemnity and Hunting Regulations**

Hereby warrant, acknowledge and agree:

1. That I am fit, in good health and that there is nothing, which renders me, unfit to undertake a hunting safari.
2. That I understand and appreciate fully the fact that I may before, during and after the completion of this safari, contract disease, be injured or killed as a result of the use of firearms, motor vehicles, aircraft or any other equipment of any nature whatsoever; as a result of the hunting of wild and dangerous animals, camping in bushveld areas, food I may eat or the liquids I may drink; or as a result of being bitten by snakes, scorpions, ticks or any other dangerous or poisonous animals or insects; or as a result of lack of care or skill or the negligence of Africa Maximum Safaris staff, its agents, employees or servants.
3. That I voluntarily assume the risk inherent in taking part in such a safari and I together with my heirs, executors and administrators, hereby release Africa Maximum Safaris CC, its servants and agents from any duty of care towards me.
4. That I resume full responsibility for the behavior of all members of my party and hereby indemnify Africa Maximum Safaris CC and its agents any claims of whatsoever nature may be made by or on behalf of any third party arising directly or indirectly as a result of the activities of myself or any other member of my party.

**Regulations:**

1. Any animal wounded will be accepted as an animal hunted and paid for. (When blood, hair, bone or stomach fluid is found). Or in any situation where it is evident to the PH that the animal was hit in the manner that it acted; especially with a gut shot.
2. Employ staff with skill and consideration, and with understanding to the value of life.
3. Agree to obey the laws of the country, which I find myself hunting in.
4. I acknowledge the fact that I am hunting with a licensed guide and will conduct my hunting in such a manner that I will not partake in any unlawful practice that may harm the reputation or cause legal action or cause prosecution by law to Africa Maximum Safaris, the Outfitter or any guide or person in service of Africa Maximum Safaris.
5. No alcohol will be used while on the hunt and or while handling a firearm.
6. Client will be required to shoot their rifles in at the rifle range before any hunting will be conducted. Every client is expected to shoot a grouping of 3 shots at a 100 yards to the satisfaction of the guide. If a firearm is rented from Africa Maximum Safaris cc, clients will be expected to shoot a 3 shot grouping at a 100 yards.

7. Any medical condition should be reported to the outfitter before commencing on the hunt. If chronic medicine is used also explain and give instructions of use to Outfitter in case of an emergency.
8. Any animal wounded and not recovered will be subject to a 15% Government tax on top of the trophy fee. Trophy not exported.
9. Rifle rental at \$ 70 per day per client. Any damage to a firearm will be for the clients account. Ammunition is charged at cost price.

Notes:

1. Trophy dip, pack and ship: Please note that the dip and ship period of raw trophies is 10-12 months. If trophy taxidermy is done with a taxidermist in South Africa, the taxidermist will confirm turn around period with hunter.
2. Please advise if you will be paying with credit card, so we can process payment on last night in camp to allow for time to contact your bank if your credit card is blocked for processing payment in South Africa. It is a frequent problem with foreign cards.
3. Wi-Fi is available at Africa Maximum's main camp at Woodstock farm. The cost for Wi-Fi is \$25 for 5 days. Do remember that our Wi-Fi can be off at certain times as we are in a remote area and our service provider has difficulty in supplying to our location. I have read and understand the content of this indemnity and hunting regulations and have taken note of the account settlement and price list.
